

The book presents this complex area of law with clarity but without oversimplification. There is a comprehensive coverage of local authority duties and powers, to adults in need and to carers – including assessments, care planning, ordinary residence, care and support services, direct payments, NHS responsibilities, housing, MHA 1983 \$117 services, the rights of prisoners and substance misuers, safeguarding and the rights of asylum seekers. The remedies chapter has a step by step guide to complaints, ombudsman and judicial review procedures.

Luke is the Cerebra Professor of Law and Social Justice at the School of Law, Leeds University, and a solicitor with Scott-Moncrieff Associates LLP (London). Luke's work is primarily concerned with the rights of people who experience social exclusion, including disabled people and carers.
